The club will hold an Open to Centre trial for solo machines only. To be held under the National Sporting Code rules of the ACU, the Standing Regulations for trials, these supplementary regulations and any final instructions which may be issued up until the start of the trial.

Entry fees: £22.00. Cheques payable to Redditch MCC. Must include 2 x SAE. Entries will close on the 27th November 2018. Entries will be accepted up until 8:30am on the day of the trial at a cost of £24.00, but riders will not be eligible for awards or championship points. Start list and results by email (email address required OR 2 SAE'S). Results will also be posted on the Club and Centre Website.

Venue and Start Time: S. E. Davies & Sons, Edgiok Lane, Astwood Bank, Redditch. B96 6BG. 1st rider away at 9:30am, the rest at one minute intervals. The method of marking for this trial will be TSR22B. Petrol is not available at the start.

Course: The trial will be of a sporting nature and will have 2 routes, and will include a 50-50 route, half the sections from the 'A' route and half the sections from the 'B' route.

Note: Events run as open trials. Any member of an ACU affiliated club can enter the trial.
